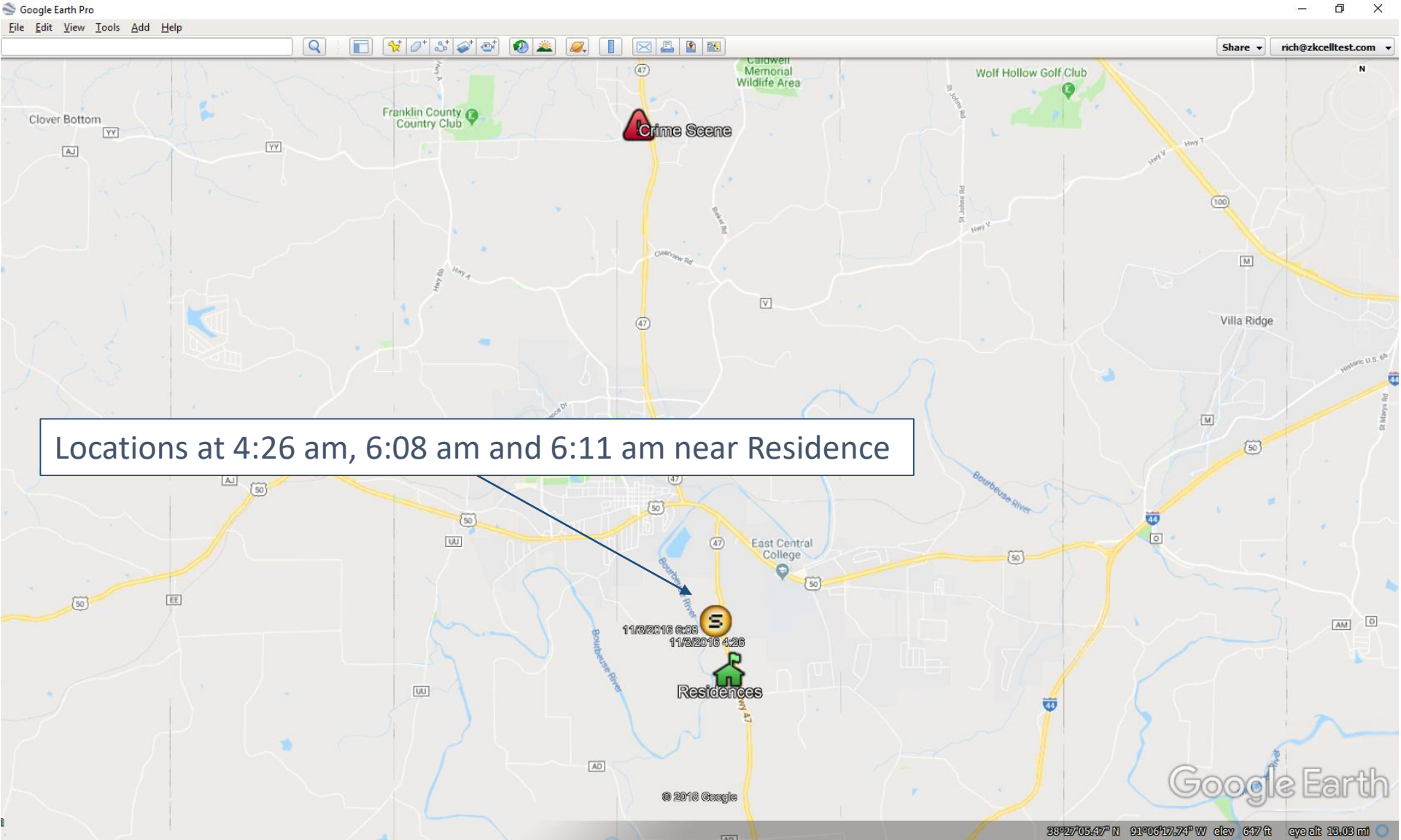

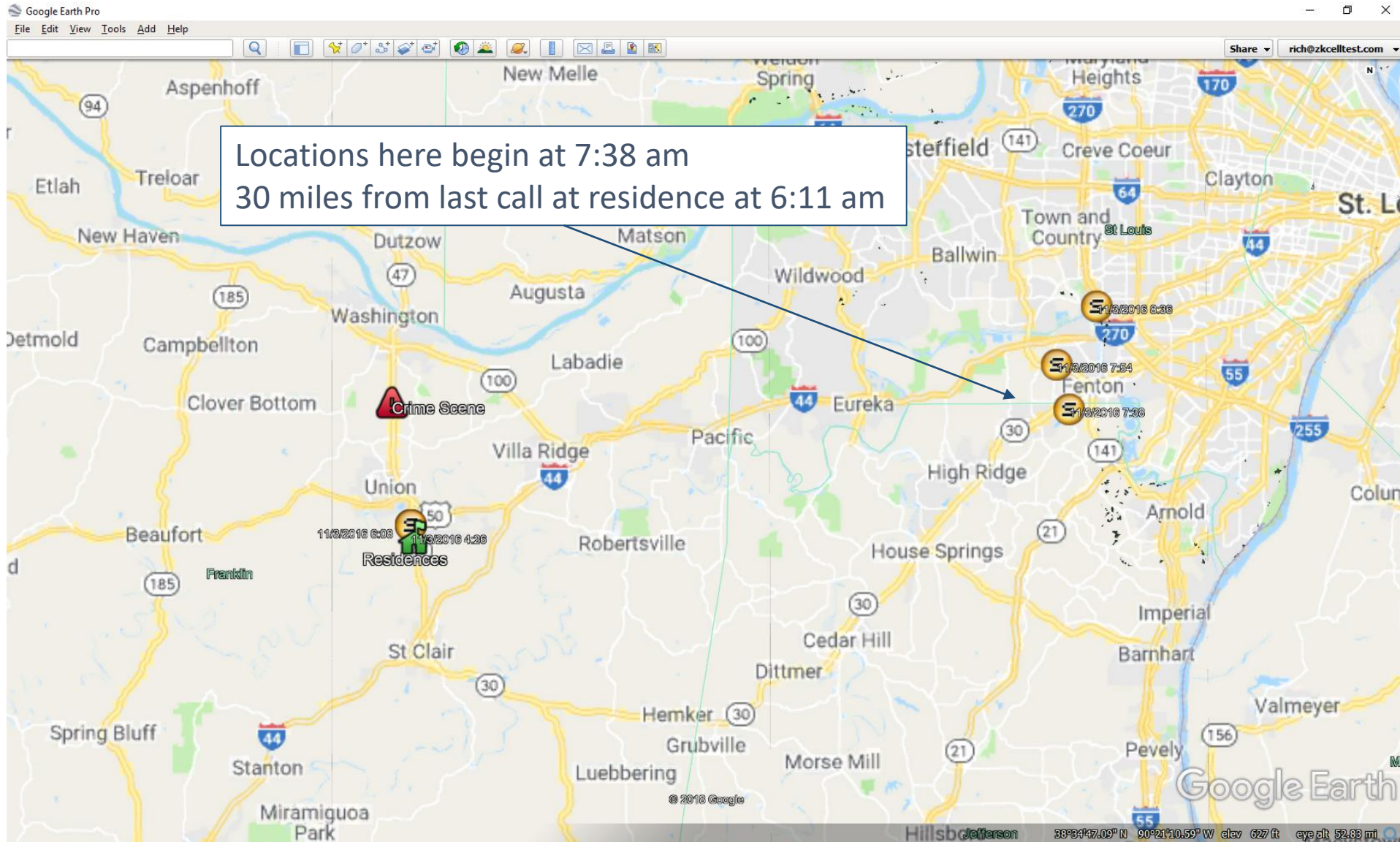
- **NETWORK EVENT LOCATION SYSTEM (NELOS)**
 - ESTIMATES LOCATION OF CELL PHONE WITHIN A STATED ACCURACY
 - INCLUDES PHONE NUMBER, CONNECTION DATE AND TIME, LATITUDE/LONGITUDE LOCATION OF PHONE, LOCATION ACCURACY

- **CALL DETAIL RECORD (CDR)**
 - EACH RECORD INDICATES A PHONE CALL, SMS OR DATA SESSION
 - INCLUDES CELL SITE LOCATION OF CELL SITE HANDLING THE CALL
 - INCLUDES AZIMUTH (DIRECTION) CELL SITE ANTENNA IS POINTING

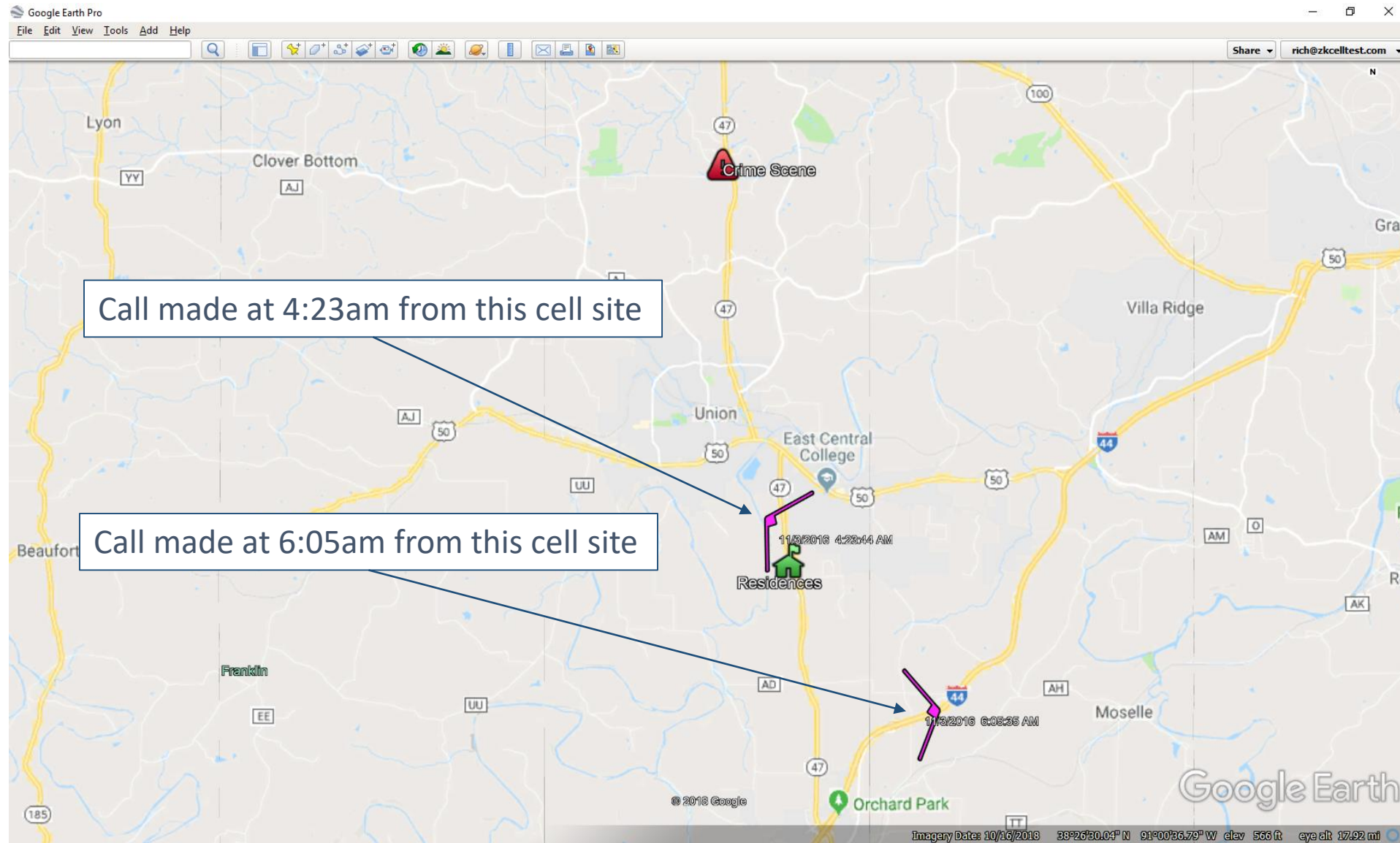

CDR - 636-249-4610 Phone location after 6am

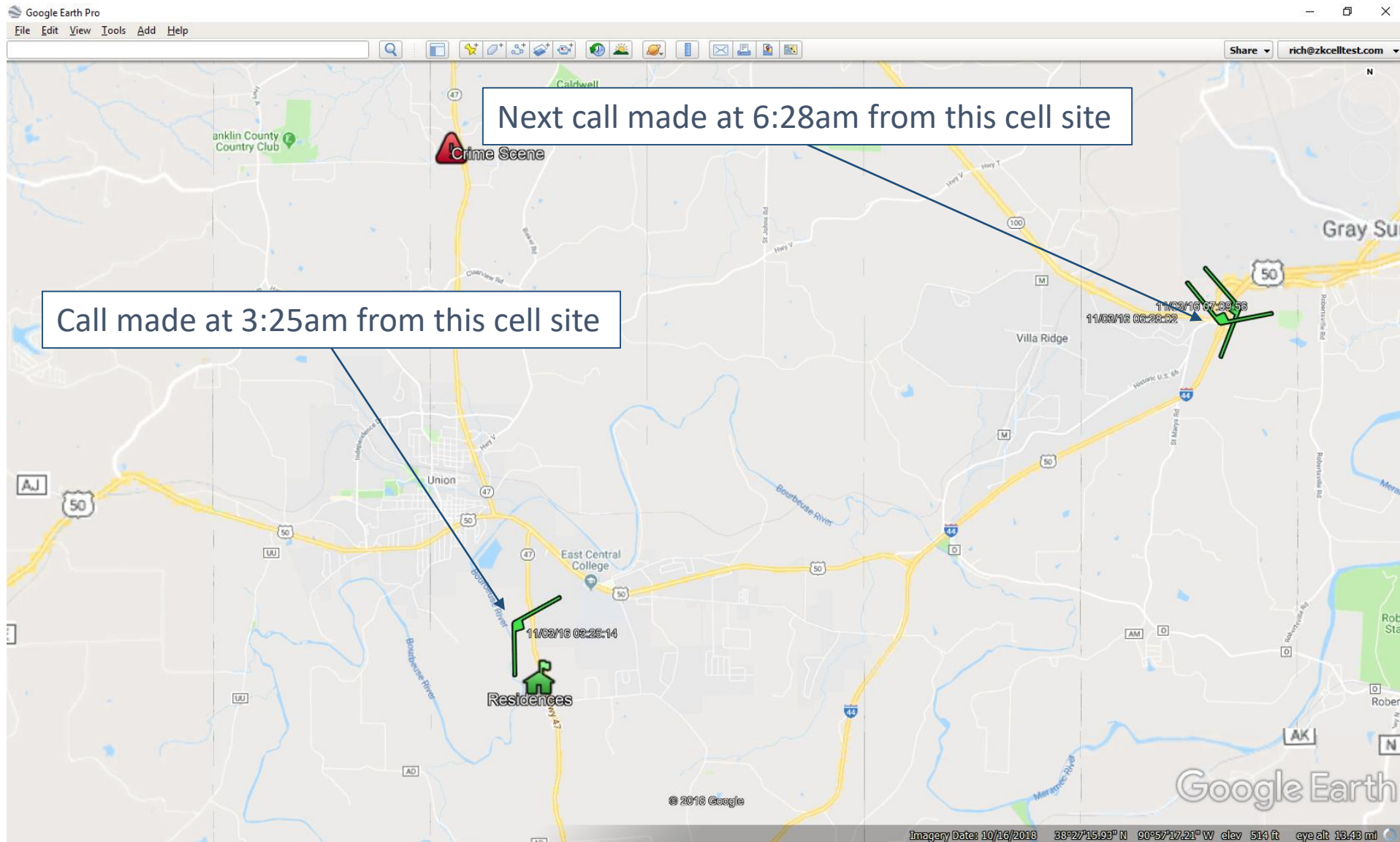

- BEGINNING SHORTLY AFTER 6AM THROUGH 10AM ON NOVEMBER 3RD THIS PHONE CALLED THREE OF THE 800 NUMBERS ON THE BACK OF KEN ALLEN'S CREDIT CARDS
